VIT is established in the year 2009, managed and governed by the Vishnu Waman Thakur Charitable Trust registered under Mumbai Public Trust Act 1950 with registration number E-172 (Palghar) dated 31/05/1988. The Institute is Self-Financing.

VIT conducts Under Graduate course of Computer Engineering-60, Mechanical Engineering-120, Electrical Engineering-60, Civil Engineering-60, Electronics and Telecommunication Engineering-60 and Computer Science and Engineering (Artificial Intelligence and Machine Learning)-60. Post Graduate Courses M.E. in Mechanical (Manufacturing systems Engineering)-18 and Master of Computer Application (MCA)-60. Institute is affiliated to University of Mumbai and approved by AICTE, New Delhi, Government of Maharashtra, and Directorate of Technical Education (DTE) with DTE Code EN3221.

The curriculum and syllabus of UG and PG are prescribed the University of Mumbai. The examination and award of degrees is done by the university.

The fee for the program is prescribed by the Fee Regulatory Authority (FRA) of the Govt. of Maharashtra.

VIT has Vision to impart total quality education by means of equipped students with knowledge and skills in their chosen stream, inculcate cultural and ethical values, identify hidden talents, provide opportunities for students to realize their full potential and thus shape them into future leaders, entrepreneurs and above all good human beings.
