iii) Redress grievance promptly.

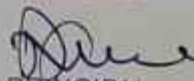
iv) Use positive friendly ways to resolve the crisis than punitive steps.

iii) After receiving complain / application the committee will decide on the merit of case regarding scope of further discussion investigation.

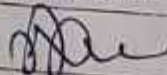
iv) GRC will meet only as and when required.

3) The members are happy to learn that the issues of minor complaints are dealt with concerned departments effectively.

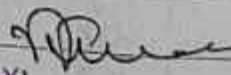

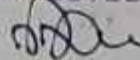
5. The following cases are observed and resolved:-
